Gambling and college athletes and coaches: A mixed-methods study

This study will use a mixed-methods design and a collaborative, multi-disciplinary approach in a racially diverse group of athletes and coaches to identify key factors that elevate risk. Addressing and preventing gambling problems requires information on the attitudes, perceptions, and motivations of athletes and coaches who gamble, which have been virtually

unexplored. Findings from this study will drive prevention and intervention strategies in college and university settings.

Strengthening Kentucky's behavioral health workforce to address problem gambling

\$97,964, Kentucky Division of Behavioral Health, Developmental, and Intellectual Disabilities (DBHDID)

The aim of this project is to enhance the ability of the existing behavioral health workforce to understand, identify, and treat problem gambling issues. Through our hybrid training course approved by the International Gambling Counselor Certification Board, we expect approximately 160 current providers will complete the basic education hours necessary to pursue certification as International Certified Gambling Counselors (ICGC-I) and an additional 60 will participate in advanced skills trainings. By expanding the membership of the behavioral treatment workforce equipped to screen for and treat gambling problems, Kentuckians who are experiencing such problems will be more likely identified and triaged to appropriate supports.

Gambling and emerging adults: Understanding risk pathways

The overall goal of this Center of Excellence project is to conduct a comprehensive, systematic study of risk factors that impact gambling among emerging adults to inform policy, education, prevention, and treatment efforts. Translational knowledge from this project will be disseminated as evidence-based materials and tools that will be useful for the general public as well as for treatment providers, policymakers, and researchers.
